- > As you are already aware, TMS Surat is in the purview of the Gujarat Self-Financed Schools (Regulation of Fees) Act, 2017. As per the recommendation of Supreme Court and the Government of Gujarat, we have submitted our proposed fee structure for the ratification of Fee Regulatory Committee, Surat for further information and approval for the year 2023-24.
- > As an interim arrangement until clarity prevails in this matter (which is currently sub-judice) the following ** provisional fee will be collected during the admission process of 2022-23

** : The provisional fee & Head of Fees will be applicable until further directions from appropriate authorities due to the pending final outcome of the sub-judice matter. The provisional fee & amount collected under these heads will be appropriated under different / new heads as decided / ordered by the competent authority and School Managing Committee based on the final outcome of the sub-judice matter. You will be intimated about the details of approved heads of fee and the amount once it is finalised.

*: Admission fee is equivalent to one month's tuition fee of the applicable level and time, in the year of seeking admission and subsequently charged in the beginning of the academic year when the student gets promoted to class I, class IX & class XI. It will be deducted from Security Deposit.

\$: Security Deposit is refunded Interest Free when the student leaves TMS-Surat after the deduction of Admission fees at different level.

%: Imprest Deposit is carried forward every year after deduction of consented expenses, and the final balance is refunded Interest Free when the student leaves TMS-Surat.

#: Mode of Payment For Tuition Fees : **NACH (ECS) mandatory**
(Monthly Fees will be applicable for all 12 months of the year including vacation and other holidays.)

#: **Late payment charges Rs. 10/- per day will be applicable, if Tuition Fees is paid after the due date**

Transport & Food services are optional

Note:

- 1) All the payment to be made in the name of - "The Millennium School, Surat"
- 2) Books, Bag, School Uniform and Shoes are not included in the provisional school fees.
- 3) In case of cheque/ draft being dishonored or ECS/ NACH is rejected a sum of Rs. 500/- including bank charges shall be applicable.
